# About the Greenhouse Gas Abatement Scheme

The NSW Greenhouse Gas Abatement Scheme (GGAS) commenced on 1 January 2003. It is one of the first mandatory greenhouse gas emissions trading schemes in the world and aims to reduce greenhouse gas emissions associated with the production and use of electricity. It achieves this by using project-based activities to offset the production of greenhouse gas emissions.

By implementing energy efficiency measures, you may be eligible to create NSW Greenhouse Abatement Certificates (NGACs) that can be sold on the market for profit. Efficiency measures installed in NSW after 1 January 2002 or ACT after 1 January 2004 may be eligible to create NGACs.

To create NGACs, parties must become accredited by the Scheme Administrator and create and register NGACs through the Scheme's Registry. 1 NGAC represents 1 tonne of greenhouse gas and trades between \$10 and \$15.

help you create NGACs sooner, cheaper and with less hassle.

At this stage, Demand Manager is accepting applications from companies to create NGACs for lighting-based efficiency upgrades that may include:

- · fitting or luminaire upgrades
- tube de-lamping or upgrades
- · lighting control systems
- · occupancy or movement sensors
- daylight linking or skylights
- fixed dimming or voltage reduction units
- industrial or commercial lighting
- · display, signal or street lighting

Demand Manager's process is a very simple one-stop-shop approach which takes care of the following:

- application and registration fees
- · record keeping requirements
- · any risks and costs of being audited
- using the Registry to create and transfer NGACs
- any dealings with the Scheme Administrator
- annual reporting requirements
- trading small batches of NGACs
- taxation implications (GST)
- · ongoing legal liability for creating NGACs
- · completing application forms and spreadsheet

## Create NGACs the Easy Way...

The process has been designed to make it simple. Just follow these easy steps to get started:

#### Step 1. Ask for a Quote

Demand Manager structures its fees on a no-win, no-fee basis with no upfront costs or charges. We will only charge fees once you are creating NGACs, based on a percentage of the NGACs created. Ask Demand Manager for a no-obligation quote for your lighting upgrade.

#### Step 2. Sign the Nomination Form

If you decide to proceed, signing the Nomination Form is the first step to get Demand Manager creating NGACs for your lighting upgrade as it enables Demand Manager to act on your behalf.

#### Step 3. Provide Further Information

In order to progress your application, Demand Manager requires further information from you. The quality of the information will also affect the number of NGACs that can be created. Generally, the following information will be needed:

- · Copy of an electricity bill for the site
- Invoice/s from suppliers showing date, place and volume of upgrade
- · Information on site operating hours
- Engineering calculation sheets, if available
- · Metering or logging data, if available

### Step 4. Start Building NGACs

From the day your upgrade is added to Demand Manager's aggregation project, you are accumulating NGACs. Demand Manager will confirm this in writing.

#### Step 5. Annual Report

Every April, Demand Manager will send you an Annual Update. If your upgrade is still in place as per the original design, just sign and return the Annual Update to Demand Manager by fax. If there have been changes to the upgrade or personnel, let Demand Manager know the details.

#### Step 6. Annual Dividend

Once you have returned the Annual Update,
Demand Manager will create the correct
number of NGACs for your upgrade and send
you a cheque for the sale of the NGACs.
Alternatively, Demand Manager can transfer
the actual NGACs if you wished to hold onto
them for sale at a later date.
